REGULATION OF MINISTER OF AGRICULTURE NUMBER 89/Permentan/OT.140/12/2011 CONCERNING

AMENDMENT TO THE REGULATION OF MINISTER OF AGRICULTURE NUMBER 37/Kpts/HK.060/1/2006 ON PLANT QUARANTINE TECHNICAL REQUIREMENTS AND MEASURES FOR IMPORTATION OF FRESH FRUITS AND / OR FRUIT VEGETABLES INTO THE TERRITORY OF THE REPUBLIC OF INDONESIA

THE MINISTER OF AGRICULTURE,

Considering

- a. that under the Regulation of Minister of Agriculture No. 37/Kpts/HK.060/1/2006 on Plant Quarantine Technical Requirements and Measures For Importation of Fresh Fruits and / or Fruit Vegetables, the provisions regarding entry points for fresh fruits and/or fruit vegetables into the territory of the Republic of Indonesia have been defined;
- b. that in order to reduce the risk of entry and spread of pest organisms of the quarantined plants, it is necessary to redetermine the entry points for fresh fruits and / or fruit vegetables into the territory of the Republic of Indonesia;
- c. that based on the considerations of point a and point b above, it is necessary to amend the Regulation of Minister of Agriculture Number 37/Kpts/HK.060/1/2006;

THE REGULATION OF MINISTER OF AGRICULTURE CONCERNING AMENDMENT TO THE REGULATION OF MINISTER OF AGRICULTURE NUMBER 37/Kpts/HK. 060/1/2006 ON PLANT QUARANTINE TECHNICAL REQUIREMENTS AND MEASURES FOR IMPORTATION OF FRESH FRUITS AND / OR FRUIT VEGETABLES INTO THE TERRITORY OF THE REPUBLIC OF INDONESIA

Article I

Several provisions in the Regulation of Minister of Agriculture No. 37/Kpts/HK.060/1/2006 on Plant Quarantine Technical Requirements and Measures For Importation of Fresh Fruits and / or Fruit Vegetables Into The Territory of The Republic of Indonesia shall be amended as follows:

1. Provision of Article 17 shall be amended, so it red as follows:

Article 17

Designated entry points for fresh fruits and / or fruit vegetables as referred to in Article 4, point b, shall consist of:

- a. Seaport of Tanjung Perak, Surabaya;
- b. Seaport of Belawan, Medan;
- c. Soekarno-Hatta International Airport, Jakarta, and
- d. Seaport of Makassar

2. Other provisions in the Regulation of Minister of Agriculture No. 37/Kpts/HK.060/1/2006 On Plant Quarantine Technical Requirements and Measures For Importation of Fresh Fruits and / or Fruit Vegetables Into The Territory of The Republic of Indonesia shall be stated to still remain valid.

Article II

This Ministerial Regulation shall come into force 3 (three) months after commencing on its enacted date.

In order that any individual knows it, this Regulation of Minister of Agriculture shall be published in the State Gazette of the Republic of Indonesia.
