AMENDEMENT TO THE REGULATION OF THE MINISTER OF AGRICULTURE NUMBER 18/Permentan/OT.140/2/2008 ON PLANT QUARANTINE REQUIREMENTS AND MEASURES TOWARD IMPORTATION OF LIVE PLANT PRODUCTS IN FORM OF FRESH BULB VEGETABLES INTO THE TERRITORY OF THE REPUBLIC OF INDONESIA

WITH THE MERCY OF GOD THE ALMIGHTY,

THE MINISTER OF AGRICULTURE,

- **Considering** : a. that under the Regulation umber 18/Permentan/OT.140/2/2008 on Plant Quarantine Requirements and Measures towards Importation of Fresh Plant Products in Form of Fresh Bulb Vegetables into the Territory of the Republic of Indonesia has been stipulated entry point for live plant products in form of fresh bulb vegetables into the Territory of the Republic of Indonesia;
 - that in order to reduce the risk of entry and spread of quarantine plant destruction organism, its is necessary to re-<u>determine</u> entry points for live plant products in form of fresh bulb vegetables into the Territory;
 - c. that based on the consideration of point a and point b above, it is necessary to amend the Regulation of the Minister of Agriculture No. 18/Permentan/OT.140/2/2008;

HAS DECIDED:

To Stipulate : THE REGULATION OF THE MINISTER OF AGRICULTURE CONCERNING AMENDEMENT TO THE REGULATION OF THE MINISTER OF AGRICULTURE NUMBER 18/Permentan/OT.140/2/2008 ON PLANT QUARANTINE REQUIREMENTS AND MEASURES TOWARD IMPORTATION OF LIVE PLANT PRODUCTS IN FORM OF FRESH BULB VEGETABLES INTO THE TERRITORY OF THE REPUBLIC OF INDONESIA

Article I

Several provisions in the Regulation of The Minister of Agriculture Number 18/Permentan/OT.140/2/2008 regarding Plant Quarantine Requirements and Measures Toward Importation of Live Plant products in Form of Fresh Bulb Vegetables into the Territory of Republic of Indonesia shall be amended as follows :

(1) Provision of Article 16 shall be amended, so it red as follow :

Article 16

Designated entry points which are permitted to be place of entering live plant products in form of fresh bulb vegetables as mentioned which will be imported into the Territory of the Republic of Indonesia, are as follow:

- 1. Seaport of Tanjung Perak, Surabaya.
- 2. Seaport of Belawan, Medan.
- 3. Soekarno-Hatta International Airport of Jakarta.
- 4. Seaport of Makassar.
- (2) Other Provisions in the Regulation of Minister of Agriculture Number 18/Permentan/OT.140/2/2008 regarding Quarantine Requirements and Measures Toward Importation of Live Plant products in Form of Fresh Bulb Vegetables into the Territory of Republic of Indonesia shall be stated to still remain valid.

Article II

The Regulation shall come into force 3 (three) months after commencing on its enacted date.

In order that public may take cognizance of it, this Regulation of Minister of Agriculture shall be published in the State Gazette of the Republic of Indonesia
